

**COMMERCIAL TERMS & CONDITIONS FOR TRANSPORTATION OF 20/25 MVA X-mer 132/33 KV oil filled Transformer tank from 220 KV GSS Kishangarhbass (Alwar) to 132 KV GSS Lakheri (Bundi) including Loading, Transportation, Unloading (with insurance)**

1. The work is to be carried out by contractor hence all precautionary measures shall be required to be taken at contractor end. The department shall not be responsible for any accident or miss happening.
2. All T & P labour, Trailer for transportation etc. required shall be arranged at contractor level.
3. The work should be completed within 20 days from the date of issue clearance for the transportation of Tower Material.
4. The work will be carried out under the control and strict supervision of Assistant Engineer (T&C) R. R. V. P. N. Ltd., Sawai Madhopur
5. 100% payment shall be arranged through A/c pay cheque by the A. O. (T&C) R. R. V. P. N. Ltd., Sawai Madhopur after statutory deduction from your bill on receipt of bill duly verified by the Assistant Engineer -in-charge of the work and countersigned by the Executive Engineer (T&C) R. R. V. P. N. Ltd., Sawai Madhopur.
6. Presentation of bill:- Bill of total work carried out shall be prepared in triplicate by the contractor and checked by the Assistant Engineer In-charge of the work and the same will be submitted to the Executive Engineer (T&C) R. R. V. P. N. Ltd., Sawai Madhopur. The Executive Engineer (T&C) R. R. V. P. N. Ltd., Sawai Madhopur shall forward the same to the Accounts Officer (T&C) R. R. V. P. N. Ltd., Sawai Madhopur for payment after deducting taxes as applicable.
7. In case any delay in completion of the work a penalty @ 1/2 % per week or part thereof subject to maximum 10% value of delayed/ unexecuted work shall be imposed and recovered from your bills.
8. The quantity of work may be increased/ decreased by 10% as per actual site conditions/ requirement.
9. Proper work quality shall be ensured and checked by the Field Officers strictly as per specification of the 'G' Schedule etc. & record a certificate to this effect in the MB.
10. Contractor shall have to submit a certificate every month that your establishment cover under the Employees Provident Fund and Misc. Provision Act, 1952 and is having a separate code number with the Provident Fund Commissioner and also that the Provident Fund Contribution in respect of all the employees employed by you along with employer's share of contribution etc. is being deposited with the Provident Fund authorities and shall also submit charges in respect of all the employees engaged by you shall also submit charges in respect of all the employees engaged by you for the said work with RVPN along with details of the employees, their wages and the amount contribution as per RVPN CPF rules every month. Dispute : All disputes, difference, questions whatsoever arising between the Nigam and contractor upon or in relation to or in connection with the contract shall be decided to have arisen at Sawai Madhopur (Rajasthan) only and no courts other than courts in Jaipur shall have jurisdiction to entertain the same. In case of dispute between order placing authority and contractor the decision of the CE (T&C-Jpz) Jaipur will be final and binding on both parties.
