#### Terms and conditions:

1. The salary of the vehicle driver (having commercial vehicle driving license) will be paid by the owner of vehicle (if vehicle is not driven by the owner himself & the driver is engaged.)
2. All types of the liabilities of the vehicle will be borne by the contractor / vehicle owner e.g. taxi permit, insurance, fitness, registration & pollution certificates, etc.
3. The rates / prices are firm inclusive of all taxes, duties. R&M charges of the vehicle contribution to CPF/EPF ESI & other liabilities expect service Tax which will be paid extra by the NIGAM if applicable on production of document.
4. Income Tax & other taxes will be deducted at source by the NIGAM.
5. In case of the night halt at the place other than that of headquarter, a sum of Rs. 200/- per night shall be paid for the driver.
6. If any charges of toll tax, will be borne by the NIGAM.
7. The monthly payment shall be made as under :
  - a. For the first 1500 kms or less Rs. 20000/- per month (service tax extra if applicable).
  - b. For additional running of vehicle (more than 1500 kms ) @Rs. 7.25 per kms, maximum upto 2200 kms.
