
## G – Schedule

### TERMS & CONDITION :-

1. For first 1500 KM s or less. 20,000/- per month ( Service tax extra if applicable )
2. For additional running of vehicle ( more than 1500 KMs ) the rate payable @ Rs. 7.25 per KM.
3. Hired vehicle shall be used as per jurisdiction of the office where deployed . in case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver .
4. The maximum celling of Rs. 25075/- per month ( Service tax extra if applicable ) for 2200 KM for office having jurisdiction of more than One district .
5. All taxes except toll tax shall be borne by the individual / contractor / firm. Reimbursement of toll tax paid the individual / contractor /firms shall be made on production of receipt of payment of toll tax.
6. The Vehicle is not to be more than 6 years old . Only vehicle taxi permit having valid documents shall be considered
7. The Vehicle hired from **01-06-2017 to 31-3-2018 ( 10 Months )** & Bill is to be submitted in triplicate and payment shall be arranged on monthly basis.
8. 9. Consent is to be provided up to **06.06.2017** up to **3.00PM**.
10. The Income tax & other tax will be deducted at source by the NIGAM
11. All types of the liabilities of the vehicle will be borne by the contractor/ vehicle owner e.g. taxi permit insurance , fitness , registration & pollution certificate etc.
12. The salary of the vehicle driver will be paid by the owner of the vehicle ( if the vehicle is not driven by the owner himself & the driver is engaged
13. The rates / prices are firm inclusive of all taxes , duties , R&M Charge of vehicle contribution to CPF / EPF / ESI & other liabilities except service tax which will be paid extra by the NIGAM if applicable on production of document.
14. Performance security @ 5%of tender cost will be deposited by the successful tenderer and same will be refunded on successful completion of contract.
15. An agreement need to be signed between the procuring entity and vehicle provider.
16. The Process shall be governed by RTTP Act.2012 and RTPP rules 2013.
17. All terms & condition of Govt of Rajasthan Finance Deptt. Circular No. F.9(1)/FD.1(1) Budget / 2015 Jaipur dtd. 15.07.15 are also applicable.
18. **Price escalation:** Rates of hiring of vehicle will be change as & when revised by finance deptt. Govt. Raj. and same adopted by the Nigam. The revised rates shall be applicable from date of such revision.
