



Terms and condition of hiring of vehicle

- The maximum ceiling of Rs. 23625/- per month (Service tax extra if applicable) for 2000 Kms for office having jurisdiction of one district (applicable for Assistant Engineer (MPT&S) RVPN Barmer)
- However taxi vehicle hired under the above categories plys less than maximum ceiling of 2000 Kms then the monthly payment shall be made as below
 - For first 1500 Kms or less 2000 per month (Service tax extra if applicable)
 - For additional running of vehicle (more than 1500 kms) @ 7.25 per KM.
- All taxes except toll tax shall be borne by the individual / contractor /firm. Reimbursement of toll tax paid by the individual / contractor /firm shall be made as per production of receipt of payment of toll tax.
- All legal deduction (if applicable) such as income tax (TDS) shall be as per rule /law applicable at the time of payment. By nigam Rules.
- An agreement need to be signed between the procuring entity and taxi vehicle provider.
- The vehicle should not be more than 06 year old and condition of vehicle satisfactory.
- The vehicle shall remain at the disposal of officer in charge to keep this shall be parked at suitable place or in the garage as per advice by officer in charge. The driver shall be dressed properly.
Normal duty hours of the driver will be remaining 12 hour in a day as per advice of officer in charge. The alternative driver for next 12 hours shall be arranged by the contractor as per requirement of the officer in –charge.
- Hired vehicle shall be used as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver.
- The daily log book will be completed by the driver after the completion of journey.
- All repair works expenditure will be borne by contractor, no rent of vehicle will be paid to the contractor during the repair work.
- Performance security on the basis of annual expenditure on hiring of vehicle as provided in Rajasthan Transparency in public procurement rule 2013 shall be taken from the individual /contractor Firm.
- The contractor will responsible for depositing the tax & RST Charges insurance of vehicle as per rules. Document & Driving License will be check for validity.
- All terms & condition of Govt of Rajasthan Finance Deptt. Circular No. F.9(1)/FD.1(1) Budget / 2015 Jaipur dtd. 15.07.15 are also applicable and it is enclosed with this G schedule
