

1. Bid documents are to be purchased from this office from TA to SE (T&C) RVPNL, Sirohi.
2. Procurement process will be governed by RTTP act- 2012 and RTTP Rules-2013.
3. The work is to be done as per G-schedule provided with bid documents.
4. The bid cost is non-refundable.
5. The bid rate shall be valid for 90 days from date of opening of the bid.
6. The bid shall be addressed to the TA to SE (T&C) RVPNL, Sirohi.
7. This office has right to extend the date of opening of bid if necessary.

8. The bid received late on any cost shall not be considered.
9. The incomplete bid in any respect will not be accepted.
10. The bid security as given above shall be deposited in cash or by crossed DD/Banker cheque in favour of AO (T&C) RVPNL, Sirohi.
11. The vehicle shall not be more than 6 years old. Only vehicles with taxi permit having valid documents shall be considered.
12. All the taxes except toll tax shall be borne by the individual/contractor/firm. Reimbursement of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payment of toll tax.
13. All statutory deductions, such as TDS etc. shall be made as per statutory rules applicable at the time of payment of monthly bill.
14. The rates are excluding of service Tax.
15. Any compensation payable for damage due to accident by vehicle or driver to any party/property shall be borne by the suppliers / contractor to whom contract is to be awarded. The RVPN department will not be responsible for the same.
16. An agreement needs to be signed between the procuring entity and taxi vehicle provider initially for the period 01.04.2017 to 31.03.2018.
17. All other condition as per order No. F.9(1)FD.1(1) Budget/2015 Jaipur, dated 15<sup>th</sup> July, 2015 of Finance Department of Govt. of Rajasthan shall also be applicable on individual/ contractor/firms.
