Other terms and conditions:-

1. The vehicle should not be more than 05 years old.
2. Hiring charges per day (24 Hours) should be inclusive of salary & all kind of wages of driver. Toll tax and parking charges will be paid by the Nigam.
3. The car will remain available for 24 hours under RCAO (T&C) RVPN Jodhpur. Driver will not leave the head quarter without permission of the controlling officer.
4. Repair and maintenance of vehicle will be carried out by owner of the vehicle at his own cost.
5. The payment of HSD is reimbursed to the contractor on an average 15 Km per litre and lubricant one Litre oil for every 1000 Km run of vehicle on production of original bills of dealer of HSD/Lubricants and arranging you from circle AO.
6. Registration, insurance, road tax, renewal of fitness certificate, pollution under control, license, R&M of vehicle, CPF/GPF & other required liabilities/formalities will be completed timely by the owner of vehicle. In case any penalty is imposed due to incompleteness of these papers/ documents, same shall be borne by the owner of the vehicle.

7. Performance Security on the basis of annual expenditure on hiring of vehicle as prescribed in Rajasthan Transparency in Public Procurement Rules 2013 shall be taken from owner of the vehicle.
8. All taxes except service tax & toll tax shall be borne by the individual/contractor/firm. Reimbursements of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payment of toll tax.
9. All statutory deductions such as income tax (TDS) shall be made as per law/rules applicable at the time of payment.
10. The work will be carried out under the relevant provisions of RTPP Act 2012 and RTPP rules 2013.
11. Without Bid Security the tender will not considered.
12. Log book of vehicle shall be maintained by the controlling officer with due signature of driver & user per day.
13. Bill on monthly basis will be prepared in triplicate for verification of controlling officer & onward submission to AO (T&C) Jodhpur for payment through RTGS to individual/contractor/firm Account.
14. If services are not found satisfactory, the work order may be terminated with a notice of 7 days.
15. If the behaviour of driver is not found satisfactory, vehicle owner shall replace the driver within a week.
16. In case of failure/breakdown of vehicle, another vehicle shall be arranged by owner within 24 hrs. Otherwise other vehicle shall be hired from market by RVPN on the available rate & such amount shall be deducted from owner's bill.
17. In case of non-availability of vehicle, Rs. 300/- per day as a penalty shall be deducted from your bills.
18. No responsibility shall be borne by RVPN on account of compensation due to road accident or any other reasons.
19. In case of any dispute, the decision of Zonal Chief Engineer (T&C), RVPN, Jodhpur will be final & binding for the both parties. The jurisdiction of court will be Jodhpur only.
20. Tenderer should mention NIT no. on the sealed envelope of Tender.
