

1. The Bids are being invited by Executive Engineer(MPT&S) RVPN,Bhilwara having office at 220 KV GSS Premises,Bapu nagar, Bhilwara and bid specification are to be purchased from this office . 2. The procurement process shall be governed by RTPP Act 2012 and RTPP Rules 2013.
3. The procurement is being done through single stage bid.
4. The work to be done as per G schedule provide with bid specification .
5. The work under NIB No.01/21-22 shall be for period of financial year 2021-22 as specified in work order. Bill is to be submitted monthly and payment shall be arranged on monthly basis.
6. Only reputed firms who have experience of aforesaid mentioned work shall be considered.
7. Vehicle shall be not more than 6 years old. Vehicles more than 6 year old will not be considered. Only vehicles with taxi permit having valid document shall be considered.
8. The bid cost (Non refundable) as given above shall be deposited by crossed Demand Draft/ Bankers cheque /online payable in the name of Accounts Officer (T&C) RVPN, Bhilwara. **For bid security bidder shall submit Bid security declaration form of Rs.- 50/- with the bid.**

10. The bidder will have to quote the firm prices inclusive of all taxes and duties, insurance POL and other related cost but exclusive of GST and toll tax, Contractor may opt to accept changes in price if any made by Govt.of Rajasthan during the tenure of contract.
