Terms & Conditions:-

1. The tender to be purchased from O/o SE (MPT&S), RVPN, Jodhpur & Bid should be addressed to the Superintending Engineer (MPT&S), RVPN, Jodhpur along with TN number.

2. The procurement process shall be governed by RTPP Act 2012 and RTPP Rules 2013 and vide Circular No. F.2 (4)/FD/SPFC/2017 Jaipur dated 28.02.2019 issued by the Finance Department, Govt. of Rajasthan Jaipur and Order No. /RVPN/DS/GAD/F. Norms of vehicle /18-19/D.148 Jaipur, Date 30.05.2019 in terms of order issued by the Secretary (Admn.) RVPN, Jaipur and amendment made time to time.
3. The procurement is being done through single stage bid.
4. The bid shall be submitted in closed/ sealed envelope duly super scribed as "Hiring of Vehicle for Bid No....."
5. The Vehicle is hired for first 1500 kms or less@ 24,000/- per month (GST extra, if applicable) & for additional running of vehicle (more than 1500 kms) the rate payable will be @ Rs.9.00 per km.
6. The vehicle shall not be more than six years old. Only vehicles with taxi permit having valid documents shall be considered.
7. The bid cost (non refundable) and bid security as given above shall be deposited in cash or crossed demand draft Payable in the name of the concerned "Accounts Officer (T&C), RVPN, Jodhpur / Bhadla / Jaisalmer / Barmer / Sirohi".
8. Photocopies (self attested) of registration certificate, insurance, road tax, driving license, pollution under control etc. relevant documents are essentially to be submitted along with bid.
9. The vehicle is to be hired for the period 01.04.2020 to 31.03.2021.
10. The hired vehicle should be made available for 24 hours a day.
11. Any compensation payable for damage caused due to accident by your vehicle driver to any party / Property shall be born by you. The department will not be responsible for the same.
12. The safety & security of the vehicle shall not be responsibility of the RVPN and it will be at the risk of the bidder.
13. Monthly bill will be prepared and submitted in the office of in charge of vehicle. The same will be verified by in charge of vehicle and submitted to the concerned Accounts Officer & the Accounts Officer will arrange payment through RTGS / NEFT etc.
14. Night Hault charges will be Rs.300/- (Three Hundred) only per night will be paid by Nigam outside head quarter stay.
15. Income tax and any other taxes if applicable will be levied/ charged as per norms.
16. In case of any outage/ damage of vehicle then substitute of the same may be arranged within 24 hrs.
17. In case of non-availability of vehicle, Rs.200/- recovery will be made per day besides nonpayment of daily pro rate.
18. RVPN has right to reject any bid without assigning any reasons.
19. Period of contract may be reduced as per requirement.
20. RVPN has all right to terminate the contract with a notice period of seven days.
21. If services of hired vehicle found unsatisfactory the contract would be terminated immediately without any notice period.
22. All the disputes arising out of contract between RVPN and Contractor, shall be subjected to the jurisdiction of the court situated at Jodhpur only.
23. All other duties, taxes of vehicle is to be bear by vehicle owner. Only toll tax, if any paid by vehicle driver/ owner will be reimbursed by RVPN on submission of receipt of toll tax.
24. Performance security on the basis of annual expenditure on hiring of vehicles as provided in Rajasthan Transparency in public procurement rules 2013 shall be deposited by successful bidder or shall be deducted from monthly running bill which will be refunded after successful completion of contract otherwise will be forfeited.
25. Tender without bid security will not be entertained.
