- 5.) In case of night halt at the place other than that of headquarter, a sum of Rs. 300/- per night shall be paid for the driver.
- 6.) If any charges of Toll Tax, will be borne by the NIGAM.
- 7)The performance security @5% of work order amount shall be deposited by contractor In the office of Accounts Officer (T&C), RVPNL Jodhpur within 03 days from date of issue of work order which shall be refunded after successful completion of work order without any interest.
