Terms & Conditions:-

- 1.) The salary of the vehicle driver will be paid by the owner of the vehicle. (if the vehicle is not driven by the owner himself & the driver is engaged).
- 2.) All types of the liabilities of the vehicle will be borne by the contractor / vehicle owner e.g. taxi permit, insurance, fitness, registration & Pollution certificates etc.
- 3.) The rates /prices are firm inclusive of all taxes, duties, R&M charges of vehicle contribution to C/PFI EPF ESI & other liabilities except s GST which will be paid extra by the NIGAM if applicable on production of document.
- 4.) Income Tax & Other taxes will be deducted at source by the NIGAM.
- 5.) In case of night halt at the place other than that of headquarter, a sum of Rs. 300/- per night shall be paid for the driver.
- 6.) If any charges of Toll Tax, will be borne by the NIGAM.
- 7.)The performance security @5% of work order amount shall be deposited by contractor In the office of Accounts Officer (T&C), RVPNL Jodhpur within 03 days from date of issue of work order which shall be refunded after successful completion of work order without any interest. If any breach of terms & conditions of work order same may be forfeited and the work order may be cancelled.
