Terms and Conditions

1. The letter should be addressed to The Executive Engineer(MPT&S) RVPN,JODHPUR .
2. The consent letters will be **accepted upto 04.00 pm on dtd. 24.04.2018**
3. The undersigned does not bind him to accept the consent and reserve the right to reject any or all of the consents without assigning any reason thereof.
4. The vehicle shall be hired for 01 years(2018-19) wef 1.05.2018 to 31.03.2019
5. The vehicle should not be more than 06 years old .
6. The vehicle is hired on rate, terms & conditions as per order no. RVPN/DS/GAD/F.Norms of vehicle/D-2058 Dtd. 16.03.2018 of the Secretary (Admn.), RVPNL, Jaipur and Govt. of Raj. Fin. Dept. Circular no. F.9(1)/FD.1(1) Budget/ 2015 Jaipur dtd. 15.07.2015. As per these circular rates applicable are as under:-
 - a. For first 1500 KMS or less Rs. 20,000/- per month.
 - b. For additional running of vehicle more than 1500 KMS the rate payable @ Rs. 7.25 per KM.
 - c. In case of night halt other than that of head quarter a sum of Rs. 200/- per night shall be paid for the driver.
 - d. The max. ceiling of Rs. 25075/- per month for 2200 KMS for offices having jurisdiction of more than one district.The above rates are inclusive of POL, R&M of vehicle. Legal expenses, Pay & allowances of vehicle driver and all applicable taxes.
7. All the risks will be on part of the vehicle owner. The contractor shall be fully responsible for safety of his vehicle & vehicle driver. The RVPN will not be responsible for any type of accident. The contractor shall have to submit an undertaking on non judicial stamp paper worth of Rs. 100/- attested by Notary Public that no payment will be paid by RVPN on account of accident either repairing of vehicle or compensation of any type, if any.
8. The vehicle as far as possible shall be parked in the office premises but at the risk of contractor
9. The vehicle will be driven by the driver having valid Taxi driving license.


10. All the relevant papers i.e. registration, insurance, fitness, permit, PUC etc. will always be kept with vehicle. Validity of documents of vehicle will be got renewed by the contractor prior to expiry otherwise this agreement will be treated as cancelled from the date of expiry of validity of required document.
11. An agreement of said contract will be executed by the contractor on non judicial stamp worth @0.25% of contract value in favor of the Executive Engineer (MPT&S), RVPNL, jodhpur on behalf of RVPN. The cost of stamp paper will be borne by the contractor and should be attested by Notary Public.
12. This order will be fully governed by the Govt. of Raj. Fin. Dept. Circular no. F.9(1)/FD.1(1)Budget/2015 Jaipur dtd. 15.07.2015.
13. The above rates are as per present circular and if any price/rate change by GOR in future, the same will be applicable for this contract
14. The payment will be made monthly by the Accounts Officer (T&C), RVPNL, jodhpur through RTGS/ NEFT for which the contractor will have to submit bill in triplicate in this office
15. The performance security @5% of work order amount shall be deposited by contractor In the office of Accounts Officer (T&C), RVPNL jodhpur within 03 days from date of issue of work order which shall be refunded after successful completion of work order without any interest. If any breach of terms & conditions of work order same may be forfeited and the work order may be cancelled.


