NOTICE INVITING TENDER

Sealed limited tenders are invited from competent and experienced Firms/ Vehicle Owners for deploying Inspection vehicle [CAR (Maruti Swift Dezire/Etios or equivalent.) / (Bolero)] with Driver, POL & Repair and Maintenance for this office for the financial Year 2018-2019, as described below on following terms and conditions:-

Terms & Conditions:-

1. The tender has to be purchased from O/O XEN (MPT&S), RVPN, Jodhpur & Bid should be addressed to the Executive Engineer (MPT&S), RVPN, Jodhpur along with TN number.
2. The procurement process shall be governed by RTPP Act 2012 and RTPP Rules 2013 and as per Finance Department, GOR Circular No. F.9 (1) FD.1 (1) Budget/2015 Jaipur, dated 15 July 2015 and accepted by RVPN Vide No. RVPN/DS (GAD)/F./16-17/D.87 Dated 06.05.2016 in terms of order issued by the Secretary (Admn.), RVPN, Jaipur.
3. The procurement is being done through single stage bid.
4. The bid shall be submitted in closed/ sealed envelope duly super scribed as "Hiring of Vehicle for Tender No. 01/18-19"
5. The Vehicle is hired for first 1500 kms or less @ 20,000/- per month (GST etc. extra if applicable) & for additional running of vehicle (more than 1500 kms) the rate payable @ 7.25 per km.
6. The vehicle shall not be more than six years old. Only vehicles with taxi permit having valid documents shall be considered.
7. The Tender cost (non refundable) and bid security as given above shall be deposited in cash or crossed demand draft/ Cheque Payable in the name of the Accounts Officer (T&C), RVPN, Jodhpur.

8. Photocopies of registration certificate, insurance, road tax, driving license, pollution under control and relevant documents are to be submitted with the bid. Each document shall be duly signed by tenderer.
9. The vehicle is to be hired for the period 01/06/2018 to 31/03/2019.
10. The working hours for hired vehicles would be 24 hours per day.
11. Any compensation payable for damage caused due to accident by your vehicle driver to any party / Property shall be borne by you. RVPN will not be responsible for the same.
12. The safety & security of the vehicle shall not be responsibility of the RVPN and it will be at the risk of the bidder.
13. Monthly bill will be prepared in triplicate and submitted in the office of incharge of the vehicle IN TRIPLICATE. The same will be verified by incharge of vehicle and submitted to the concerned Accounts Officer & the Accounts Officer will arrange payment through RTGS / NEFT.
14. Income tax and any other taxes if applicable will be levied/ charged as per norms and GST if applicable will be borne by RVPN
15. In case of any outage/ damage of vehicle then substitute of the same shall be arranged within 24 hrs.
16. In case of non-availability of vehicle, Rs.200/- recovery will be made per day besides nonpayment of daily on pro rata basis.
17. RVPN has right to reject any bid without assigning any reasons.
18. Period of contract may be extended if required as per RVPN rules.
19. RVPN has all right to terminate the contract with a notice period of seven days.
20. If service of hired vehicle found unsatisfactory the contract would be terminated immediately without any notice period.
21. All other duties, taxes of vehicle is to be bear by vehicle owner, only toll tax, if any paid by vehicle driver/ owner will be reimbursed by RVPN on submission of receipt of toll tax.
22. Performance security on the basis of annual expenditure on hiring of vehicles as provided in Rajasthan Transparency in public procurement rules 2013 shall be deposited by successful bidder or shall be deducted from monthly running bill which will be refunded after successful completion of contract otherwise will be forfeited.
