Consent is invited from competent & experience firms/vehicle owners/travel agency for hiring the car (Swift Dzire/Indica/Indigo and equivalent with cubic capacity of atleast 1200cc diesel version with AC etc.) with driver, diesel, & oil, repair & maintenance for the office of Addl.CE(NPP&RA), RVPN, Jaipur on the rates terms and conditions approved by finance department, GOR Circular /No.F.9 (1) FD.1(1) Budget/2015 Jaipur dated 15.7.2015 as per details given below:-

The rates, Terms & conditions as per this circular are as follows:-

1. For first 1500 km or less Rs.20000/- per month (service tax extra if applicable).
2. For additional running of vehicle (more then 1500 km), the rate shall be payable @ Rs.7.25 per km.
3. Hired vehicles shall be used anywhere as per jurisdiction of this office where deployed. In case of night halt other than of head quarter a sum of Rs.200/- per night i.e shall be paid for the driver.
4. The maximum ceiling of Rs.27250/- per month (Service tax extra if applicable) for 2500 Km for official use in respect of those offices whose functional and operational jurisdiction is spreading over the entire state of Rajasthan.
5. All taxes except Toll tax shall be borne by the individual/contractor/firms.
6. Reimbursement of Toll Tax paid by the individual/contractor/firm shall be made on production of receipt of payment of Toll Tax.


Other conditions shall be as under:-

1. The Vehicle shall not be more then 5 years old. Only vehicle having Taxi permit with valid documents like Taxi permit, Insurance, Registration certificate, Pollution under control certificate ect. shall be considered.
