Consent is invited from competent and experienced firms/vehicle owners/ transporter for deploying vehicle (Maruti swift desire/Indigo etc.) with Driver, R&M, and POL for a period of 9 months i.e. from 01.07.2016 to 31.03.2017 on the rates, terms and conditions approved by Finance Department GOR vide circular No.F.9(1)FD.1(1) Budget/2015 dt.15.07.2015 as per details given below:-

The rates as per circular dt.15.07.2015 issued from Finance Department GOR are as follows:

1. For first 1500kMs or less, Rs.20,000/- per month (Service tax extra, if applicable)
2. For additional running of vehicle (more than 1500kMs), the rate payable @Rs.7.25 per kM.
3. Hired vehicles shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs.200 per night shall be paid for the driver.
4. The maximum ceiling of Rs.25075/- per month (Service tax extra, if applicable) for 2200kMs for offices having jurisdiction of more than one district.
5. All taxes except toll tax shall be borne by the individual/contractor/firm.
Reimbursement of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payment of toll tax.
6. All legal deductions (if any applicable) shall be made as per Law/Rules applicable at the time of payment.
7. Performance security on the basis of annual expenditure on hiring of vehicles as per RTPP Rules, 2013 shall be taken from the individual/contractor/firm.
8. Any compensation payable for damage caused due to accident by your vehicle/driver to any party/property shall be borned by contractor/firm/vehicle owners/transporter. RVPN will not be responsible for the same.
9. The working hours for hired vehicle would be 24 hours per day.

Other conditions shall be as under:

1. Vehicle shall not be more than 6 years old. Vehicles with taxi permit having valid documents i.e. registration certificate, insurance, road tax, driver license, pollution under control & other relevant documents shall only be considered.
2. The bill is to be submitted monthly and payment shall be arranged on monthly basis.
