NOTICE INVITING QUOTATION



The quotation with all necessary documents will be received in this office up to 11.10.2019 (up to 3.00PM) and it will be opened on the same day at 04.00PM.

Term & Conditions


1. **PRICES:-** The rates quoted by the contractor shall be firm in all respect till completion of the entire work on store of AEN – II (M&F), RRVPNL, Heerapura.
2. **PAYMENT:-** 100 % payment shall be made after satisfactory completion of total work as per specification and up to the entire satisfaction of the in-charge of the work. The payment shall be made by the Accounts Officer (T&C-Rural), RVPN, Jaipur on receipt of verified bill from the consignee for the completed work. However provident fund will be deducted from the bills as per rules.
3. **Completion period:-** The work of store yard cleaning will have to be completed within a period of 30 days from the date of receipt of work order. In case the work is not completed within the stipulated completion period, penalty for late execution shall be imposed as per Nigam rules.
4. **T&P:-** ALL T&P and labor required for this work shall be arranged by the contractor at his own cost.
5. **SUPERVISION OF WORK:-** The work will be carried out as per instruction and under the supervision of officer in-charge / JEN of this office.
6. **CONTRACT AGREEMENT:-** The contractor will have to execute a Contract Agreement on Non-Judicial stamp Paper worth 500/- within in period of 7 days from the date of receipt of work order.
7. **QUANTITY:-** The area of the store yards mentioned herein is approximate only. The bill shall be prepared by the JEN (M&F) as per actual measurement of work executed by the contractor.
8. **DISPUTE:-** All Dispute / difference and question what so ever which may arise in connection with the contract shall always be deemed to have arisen in the jurisdiction of the court of Jaipur only.

9. ACCEPTANCE:- The Acceptance of order shall be conveyed within 7 days after receipt of the order, failing which it shall be presumed that all the terms and conditions of the order are accepted to the contractor.
 10. RESPONSIBILITY OF CONTRACTOR:-If any accident occurs during execution of the work with any of the worker, it will be sole responsibility of the contractor and RVPN shall not bear any responsibility for any mishap/accident. If there is any damage to the property of RVPNL the contractor will be sole responsible and amount equal to the loss will be deducted from the bill.
 11. The bill of the work shall be submitted by the contractor in triplicate to this office.
 12. The contractor shall quote his rate in the G-Schedule enclosed herewith.
