## CIRCULAR

**Sub.:- Regarding compliance of order Dt. 08.02.2016 passed by the Hon'ble High Court of Rajasthan, Jodhpur in DBCWP No. 4726/2013 which stands confirmed by the decision of the Hon'ble Supreme Court dated 16.07.2018 in Special Leave Petition (Civil) Diary No. 8056/2018 filed against the aforesaid order dated 08.02.2016.**

Before the Hon'ble High Court of Rajasthan, Jodhpur, the respondent (i.e. Vidhyut Mandal Sevanivrat Adhikari Seva Sansthan, Jodhpur) had questioned the amendment No. RVPNL/CAO (P&F)/Sr. AO / Pen/ PMCF/F.D. 1199 dated 27.03.2012 in Rajasthan Rajya Vidhyut Pensioners Medical Concession Fund 2000, by which the trustees of the said fund had taken a decision to ask the members to make further contributions to the fund in the form of term membership in place of one time membership and the same was made applicable to the existing members of the fund, i.e. including those who had become life members upon payment of onetime fee as applicable at the time of their retirement from service. The High Court has by the order dated 08.02.2016 held that the amendment could not be applied retrospectively i.e. on those pensioners who had already deposited one-time fee prior to 27.03.2012 would become entitled to uninterrupted membership for medical reimbursement and could not be asked to pay term membership again after payment of the life time fee.

It appears that as a consequence of the amendment, some of the life members who had earlier paid one-time life membership fee had again deposited amounts pursuant to the amendment dated 27.03.2012, i.e. they had also paid the Term Membership Fees/Yearly Renewal Fees for continuing benefit of medical reimbursement under the scheme uninterruptedly.

Therefore, it is enjoined upon the circle Accounts Officers of all Power Sector Companies of Rajasthan (i.e. RVUNL, RVPNL, JVVNL, Jd.VVNL and AVVNL) to refund the additional amount of PMCF Renewal/Term fee deposited by the "whole life members".


The payment shall be released on production of original receipt of Deposit (A-9) by the pensioner and due verification of Life Membership from the office record.
