

**CIRCULAR**

In reference to order no RVPN/AAO/F&R/F/102/d.106 dt 09.07.2018 and 102 (ii)/D.161 dt 20.09.2018 (RVPN F&R-1230 &1245), it has been decided that since the access rights of the PPO generation screen is centralized and presently with the office of Sr. Accounts Officer (Pension), RVPN, Jaipur, as such the procedure of issuance of Revised PPO Pre-2016 Pensioners will be as under:-

1. The PPO should be revised first manually in the proforma (Final Report-FR in short) attached herewith based on the supporting papers and documents considering the relevant Pension Rules and Regulations.
2. After revising the PPO manually as per 1 above, the scanned PDF of all the Final Reports duly signed by the concerned circle AO in a month should be sent to this Office through Mail for updating the same in IMIS Module by 20<sup>th</sup> of each month.
3. After updation of the same by this office, the revised PPO may be downloaded and verified with the Manual Final Report (FR) generated at your own level and issued to the pensioner after affixing your office seal and signature with a copy to the Sr. AO (Pension).
4. The Payment Authorities are hereby advised to compare the current month pension figures with that of the previous month figures and any change in the same should be duly recorded.
