Sub: Amendment in Rajasthan Civil Services (Medical Attendance) Rules, 2013 in Appendix- I: List of 'Approved Hospitals'

In exercise of the powers conferred under Rule 4 of the of Rajasthan Civil Services (Medical Attendance) Rules, 2013 and as per the decision of the Health Benefit Empowered Committee (HBEC), the State Government hereby includes the Pacific Medical College and Hospital, Pratap Pura, NH 27, Udaipur in Appendix -I, as "Approved Hospital" as defined in Rule 3(5) of aforesaid rules.

Note:

- (1) The Order will be effective upto 5 years from the date of issue.
- (2) The hospital shall be bound not to charge, from the State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.


