Sub: Deduction at source of the subscription of Nigam's technical workmen and remittance thereof to the Rajasthan Bijali Techniqui Shramik Kalyan Kosh Samiti (RBTSKKS).


Presently the deduction at source of subscription towards "Rajasthan Bijali Techniqui Shramik Kalyan Kosh Samiti" is being made from the monthly salary bills of the members of Samiti as per rates prescribed in the erstwhile RSEB circular No. RSEB/FA&COA/Control/F.663(II)/D.79 dated 29.4.1989.

Now the "Rajasthan Bijali Techniqui Shramik Kalyan Kosh Samiti" in its general body meeting held on 24.2.2019 has decided the following amendments w.e.f. 1.4.2019:-

"for new subscriptions, membership fee will be Rs.100/- and subscription will be Rs. 5000/- which can be deducted in ten equal installments/one time from salary of such employees"

Accordingly, all units/bill preparing officers are hereby directed to deduct Rs. 100/- as membership fee and subscription Rs. 5000/- (*in ten equal installments or one time*) from the salary bills of subscribers on receipt of authorization letter of the employee through "**Rajasthan Bijali Techniqui Shramik Kalyan Kosh Samiti (RBTSKKS)**" and the Accounts officer concerned shall remit the subscription amount as per procedure prescribed in aforesaid circular No. RSEB /FA&COA/ Control /F. 663(II)/ D.79 dated 29.4.1989.
