

Sub: **Employees' Enrollment Campaign-2017-Appeal to Employers-Regarding.**

Sir,

EPFO has launched Employees' Enrollment Campaign, 2017 for all employers to voluntarily come forward and declare details of their employees who were entitled for PF benefits between 01.04.2009 to 31.12.2016, but could not be enrolled for any reason.

- The Declaration Scheme is operational between 01.01.2017 to 31.03.2017.
- Declaration regarding un enrolled employees can be made on our website http://www.epfindia.gov.in/employers/principal_employer_portal/declaration
- The **Employee's Share** of contribution if not deducted **need not be remitted.**
- **Nominal** rate of Rupee 1 (one) per annum towards **penal damages** only is required to be paid.
- **No administrative charges** are to be payable for the contribution made under the declaration.
- Declaration can be made under the Campaign for the period for which no inquiry under section 7A of the EPF & MP Act, 1952 has been pending.
- After making online declaration in the principal employer's section of EPFO Website, employer should deposit contribution along with interest u/s 7Q @ 12% within 15 days.
- Establishments that enroll **new employees** will **not be required to remit 8.33%** of employer share towards pension under Pradhanmantri Rojgar Protsahan Yojana (PMRPY) as the **Government pays the same.**
- Principal Employer is responsible for compliance of employees engaged through contractors as per Section-8A of the EPF & MP Act, 1952 read with para 30 of EPF Scheme.
- It is requested also to upload the details of the contract awarded in Principal Employer Portal (**Website: http://www.epfindia.gov.in/employers/principal_employer_portal**).

It is therefore, requested to utilize the opportunity under Special Enrollment Campaign and ensure enrollment of all eligible employees engaged by your establishment directly or through contractors immediately and avail benefits under the campaign.
