



ORDER

Sub: Guidelines for Transplant Surgery

Ref: Order No. F. 6 (2) FD/Rules/2013 Pt-II dated 01-04-2015

With reference to the subject and above mentioned order issued by this Department the following guidelines are issued for Transplant Surgery:-

- (I) Referral Procedure-
The patient who is going to receive any of the organ transplant particularly Liver, Kidney, Heart, Lung, Bone Marrow can be referred by the committee of two specialists as under:
 - (i) HOD or One Professor or above rank specialist
 - (ii) One any other concerned/associated specialist for that particular procedure

- (II) Person Authorized for referral-
Any Government Medical College of Rajasthan, RUHS run Medical College and society run other Government Medical College shall be authorized to make such referral.
