CIRCULAR

Sub:- Payment of GST Charged in Tax Invoice to the Registered Dealer.

As per Section 31(1) & (2) of CGST Act 2017, A registered person supplying taxable goods or Services or both shall issue a tax invoice showing the description, quantity and value of goods, the tax charged thereon and such other particulars.

Accordingly payment should be made to each registered supplier/contractor on the basis of Tax Invoice of Supplier/Contractor as per GST law only. A Certificate as per Annexure 'A' regarding compliance of GST law and correct tax, is required to be taken from the Registered Dealer before making payment.


