
CONDITIONS :

1. They will not be entitled to take regular classes during the office hours.
2. If at anytime, the timing of the classes are found to be detrimental to the official duties of the employee, permission for prosecuting further studies will stand cancelled.
3. If the headquarter of the employee is changed/transferred any where from the headquarter of education institution from which permission for prosecuting further studies is granted, then such permission shall be deemed to have been cancelled.
4. For every academic year a separate permission is required to be taken.
5. Disciplinary action as per rules will be initiated, if the employee continues further studies or appear in any examination without prior permission of the Nigam.
6. The official will not be allowed any leave for studies during the course of studies of higher studies or appearing in examination except leave absolutely required in respect of the days for appearing in the said examination.
7. If at any time the official(s) is transferred from the office where he is presently posted in the interest of Nigam's work, no exemption or relaxation will however, be granted on the ground because of his prior official permission to prosecute further studies.

8. Due to studies daily/routine work of the office should not be interrupted/suffer, otherwise permission of further studies can be cancelled.
9. The Nigam will not be responsible for the shortfall in attendance during the academic year of the employee.
10. No leave shall be granted for preparation of examination.
11. The permission can be cancelled without any prior notice on administrative grounds.
12. The concerned official shall have to give written undertaking to his/her concerned A.O./A.A.O./ Branch Officer that if he/She is transferred out of the present place/station in the interest of Nigam's work, he/she will not claim for any refund of fees etc. so paid by him/her on the reasons that these was to be compensated due to the effect of such transfer.


