OFFICE ORDER

The services of Sh. 2. He will be entitled to avail gazetted holidays and will be paid 05 days casual leave. He will not be entitled to privilege leave or any other kind of leave under ESR. For each day's absence without leave 1/30th of monthly remuneration will be deducted. He will mark daily attendance through biometric machine.
3. He shall be allowed travelling allowance as per category prescribed in TA rules, based on his monthly consolidated remuneration.
4. His services may be terminated by giving 15 days notice by the competent authority.
5. He is appointed on monthly consolidated remuneration for the period upto 31.03.2020 or till the vacancies are filled up or on attaining the age of 65 years whichever is earlier.
6. He will be entitled for the payment of consolidated remuneration on satisfactory performance to be verified by the controlling officer after completion of the month. He will not be entitled to get Special pay, Dearness pay, Dearness allowance, House Rent allowance, City Compensatory allowance, Conveyance allowance. He will also not be entitled for
