- (iv) Presentation to be made in RERC on the behalf of RVPN on the hearing day.
- (v) Analysis and review of final tariff order issued / passed by RERC and review petition to be filed, if any.

B) Terms of Payment

- (i) 50% of the consultancy fee on satisfactory completion of assignment mentioned at item No. (i) to (ii) of **Point A** for the period concerned.
- (ii) 30% of the consultancy fee on satisfactory completion of assignment mentioned at item no. (iii) And (iv) of **Point A** for the period concerned.
- (iii) 20% of the consultancy fee on satisfactory completion of assignment mentioned at item no. (v) of **Point A** for the period concerned


C) Submission of petition/ reply
