Sub: Amendment in Rajasthan Civil Services (Medical Attendance) Rules, 2013 in Appendix- I: List of 'Approved Hospitals'

In exercise of the powers conferred under Rule 4 of the of Rajasthan Civil Services (Medical Attendance) Rules, 2013 and as per the decision of the Health Benefit Empowered Committee (HBEC), the State Government hereby includes the **Gangauri Hospital, Sawai Madhopur** in multispecialty category in Appendix -I, as "Approved Hospital" as defined in Rule 3(5) of aforesaid rules.

- (1) The Order will be effective upto 5 years from the date of issue.
- (2) The hospital shall be bound not to charge, from the State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.

Subject:- Clarification regarding Rule No. 3(12)(I)(iii) of Rajasthan Civil Services (Medical Attendance) Rules, 2013.

In exercise of the powers conferred under Rule 4 of Rajasthan Civil Services (Medical Attendance) Rules, 2013, following clarification on the recommendation of the Health Benefit Empowered Committee, is hereby issued in Rule 3(12)(I)(iii) of Rajasthan Civil Services (Medical Attendance) Rules, 2013 :

Negative list for dental treatment is as follows, Implants are not admissible/ reimbursed in cases of :-

1. Patients with recent history of Radiotherapy in same area.
2. Patients with acute osteomyelitis and severe osteoporosis.
3. Patients having autoimmune disorders or immunodeficiency.
4. Patients with history of intravenous bisphosphonate therapy.
5. Patients having blood dyscrasias.
6. Patients who can be treated with orthodontic treatment.
7. Patients treated with Removable Partial Denture, Crown and Bridge.
8. Patients whom orthognathic surgery can be performed.
9. Patients who have poor periodontal health.
