ORDER/CIRCULAR

Sub.- Policy decision regarding PMCF fee related issues.

The Board of Trustees, RRVPMCF Trust in its 22nd meeting held on Dt. 24.07.2019 decided to consider medical reimbursement claims of pensioners only when adequate fee has been deposited/get admissible registration by the pensioner. Following are four major types of such cases where inadequacy of PMCF fee has been noticed:-

- A. Total fees of Rs. 10,000/- has neither been deducted by AO nor deposited by pensioner at the time of retirement and subsequently pensioner has registered himself under the Scheme by depositing only one year's renewal fee i.e. Rs. 1,000/- and later on deposited balance amount of Term fee.
- B. The registration of pensioner has been made with inadmissible whole life PMCF Fee by the concerned circle A.O. prior to 01.04.2012 and later on pensioner deposited balance amount of Whole Life PMCF fee.
- C. The reimbursement claim pertains to a date prior to registration under PMCF Scheme and later on pensioner got registered under PMCF Scheme by depositing applicable fee.
- D. Cases where annual fees is not deposited at all by the registered pensioners and after a gap of few years when he has undergone some treatment and wants to be reimbursed for the same, he/she again becomes member of the Scheme (i.e. after getting treatment) by depositing annual fee alongwith applicable penalty i.e. one year's renewal fee as per order no. RVPN/AS/GAD/F&R/PMCF/F.21/D.987 Jaipur Dt. 15.12.2007.

In above cases, if pensioner wants to avail benefits under RRVPMCF Scheme in future:-

- i. Where the employee has retired on & after 01.04.2012 and in depositing annual renewal fee since registration under PMCF Scheme, balance of applicable Term Membership fees (i.e. Rs. 10,000/- or 5,000/- for pensioner) (Rs. 3500/- or 1250/- for family pensioner) shall required to be deposited. Reimbursement of medical expenses in such case shall be allowed by the concerned officer only for the treatment taken on & after the date of deposition of above balance fee.



- ii. Where the registration of pensioner has been done with inadmissible whole life PMCF Fee prior to 01.04.2012, applicable Term Membership fee (for 10 years) shall required to be deposited as a fresh registration. Reimbursement of medical expenses in such case shall be allowed by the concerned officer only for the treatment taken on & after the date of deposition of applicable Term Membership fee. However, the pensioner who has already deposited applicable Term Membership fee for 10 years, will not again be required to get fresh registration after issue of this order and reimbursement in such case will be allowed for the treatment taken on & after the date of deposition of correct Term Membership fee.
- iii. Where there has been a gap in depositing annual renewal fees (wherever applicable) for one year or more, reimbursement of medical expenses shall be allowed only for the treatment taken after the deposition of annual renewal fee alongwith penalty of Rs. 1,000/- or 350/-.

The Board of Trustees has also decided that:-

- i. If any discrepancy is found in the amount of PMCF fee deposited by the pensioner, it shall be the responsibility of JLC to ensure that correct fees is deposited and reimbursement is of the period after deposition of correct fee. Only then the case shall be forwarded to Sub-Committee/passed for reimbursement as the case may be.
- ii. Court cases due to discrepancies in PMCF Fee or for any other reasons which results in rejection of a medical bill shall be contested by the concerned Circle AO (being the custodian of the PMCF Trust and having the relevant papers and documents in his office) on behalf of the Trust and the complete financial liability (since starting of case till compliance of the decision) shall be borne by the concerned Power Company. It will not be borne by the RRVPMCF Trust.
- iii. Concerned President of Jurisdiction Level Committee is hereby instructed to ensure strict compliance of the BoT decisions and the rules/provisions of RRVPMCF Scheme & related orders issued from time to time.

ORDER

Sub.:- Regarding office of registration under RRVPMCF Scheme.

After the unbundling of erstwhile RSEB, pensioners were given the right to get themselves registered under the RRVPMCF Scheme, in any office of Power Sector company as per their convenience (circular No. RVPN/CCOA/Pension/PMCF/D.617 Dt. 12.12.2000) and vide circular no. RVPN/AS/GAD/F&R/F21/D.2233 Dt. 17.12.2003 they were given a chance to change their registration to any other officer once in their life time.

In this concern the Board of Trutees, RRPVMCF Trust in its 22nd meeting held on Dt. 24.07.2019 decided that now onwards PMCF registration of pensioners shall be done only in the office of the Company from which the employee has retired irrespective of his place of drawing pension. Option for change of office of registration under PMCF Scheme once in life time shall continue but that also shall be limited to their respective Company.

Pensioners of erstwhile RSEB may get themselves registered anywhere under the jurisdiction of RVPNL. Already registered pensioners need not change their registration as per this clause.
