ORDER

Sub: Medical reimbursement for treatment taken in the Private Hospitals/ Institutions (other than Govt. Hospitals) to the pensioners of erstwhile RSEB/Power Sector Entities.

The Board of Directors, RVPN, in its 155th meeting held on 12th August 2008, has decided to recognize some more private hospital for pensioners of the erstwhile RSEB/Power Sector Entities. The reimbursement will be restricted to maximum of rates and amounts admissible in case the treatment had been taken in Govt. Hospital/Dispensary. 




Para 4 - Rate of subscription to the fund: -

a) With a view to provide Medical Concessions to the Pensioners of the Companies who are treated as outdoor and indoor patient in a Government Hospital/Clinic/Dispensary etc., RRVPMCF has been constituted into which subscription shall be paid by the serving employees of the Companies at the following rates: -

S.No.	Category of Government Servants	Subscription per month
1.	Employees drawing pay upto Rs. 3,000/-	Rs. 49/-
2.	Employees drawing pay above Rs. 3,000/- but upto Rs. 6,000/-	Rs. 71/-
3.	Employees drawing pay above Rs. 6,000/- but upto Rs. 9,000/-	Rs. 108/-
4.	Employees drawing pay above Rs. 9,000/-	Rs. 160/-

This order shall come into force with effect from 1.1.2008.

Sub: - Scheme for grant of Medical concessions to Pensioners.

The Co-ordination Committee in its 118th meeting held on 27th May, 2008, has accorded its approval to adopt the GoR order No. F. 1 (6) FD (Rules)/ 2002 dated 19.03.2008 issued by the Finance Department, Govt. of Rajasthan, regarding amendment in the Rajasthan State Pensioners Medical Concession Scheme. Accordingly, the following amendments/substitutions/insertions and deletions shall be made in the Pensioners Medical Concessions Scheme, 1991, namely: -

1. The existing note under the heading (b) at Company Head quarter a para 3 shall be renumbered as Note 1 and a new note as Note 2 shall be inserted, namely: -
 "Note2. Extension in cost ceiling other than serious diseases like Heart, Cancer, Kidney, Second opinion of Medical Board/other specialist doctor shall be necessary."

2. The existing sub-para (iii) (i) of para 3 shall be substituted by the following, namely: -
 "3 (iii) (i) The cost of Hearing Aid will be reimbursed as under: -

(i) For the first time:

	Cost of Hearing Aid	Limit of reimbursement
(a)	First Rs. 5000/-	100%
(b)	Next Rs. 5000/-	80%
(c)	Rest amount	50% subject to maximum of Rs. 10000/-

An example of calculation of cost of reimbursement: if the cost of hearing aid is Rs. 20,000/-, then reimbursable amount will be Rs. 5,000/-+Rs 4,000/-+Rs 5,000/- = Rs. 14,000/-

- (ii) In case the Hearing Aid equipment is required to be purchased again on the opinion of the competent authorised medical attendant and that the earlier equipment is beyond repairs, the reimbursement would be limited to 50% on the basis of above calculation."

3. The existing item (c) of para 3 (B) (ii) shall be substituted by the following, namely: -

"(c) For Stent/Stents: -
 For one Stent Rs. 40,000/- or actual expenses, whichever is less; and for more than one Stent Rs. 75,000/- or actual expenses, whichever is less."



For one Stent Rs. 32,000/- (80% of Rs. 40,000/-) or actual expense and for more than one Stent Rs. 60,000/- (80% of Rs. 75,000/-) or actual expenses on the Stents, whichever is less."




