


Accordingly, following amendments are hereby made in the Ministerial Staff Regulations, 1962, namely: -

- (A) 90% of vacancies by promotion on the basis of Seniority-cum-Merit from amongst Junior Accountants who have rendered at least five (5) years service as Jr. Accountants.
- (B) 10% of vacancies by Fast Track Promotion Scheme on the basis of Merit-cum-Seniority from amongst those Jr. Accountants who are qualified Chartered Accountants from the Institute of Chartered Accountants of India or Cost Accountants from the Institute of Cost Accountants of India having five years service experience as Junior Accountants.
However, if any vacancy of this quota remains unfilled, due to non-availability of suitable candidates in a particular year, then such unfilled vacancy shall be merged with promotion quota of (A) above for appointment on 'Seniority-cum-Merit' basis in that year."




MEMORANDUM

Subject :- Clarification regarding inclusion of adoptive parents in the definition of family under the Rajasthan Civil Services (Medical Attendance) Rules, 2013.

A question has been raised for clarification as to whether the legally adoptive parents of a Government Servant, who are dependent on Government servant, irrespective of where they reside, are covered in the definition of 'family' under sub-rule (9) of Rule 3 of Rajasthan Civil Services (Medical Attendance) Rules, 2013 or not ?

The matter has been examined and it is clarified that legally adoptive parents who are dependent on the Government servant, irrespective of where they reside, shall be member of family as 'parents' as defined in sub-rule (9) of Rule 3 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013 provided that in any circumstances the real parents shall not be member of the family under the aforesaid rules.

It is also clarified that if the adoptive father has legally more than one wife, only senior most will be adoptive mother and others being 'step mothers' will not include in the definition of family as 'parents' under the aforesaid rules.





- 1) Accordingly, following new proviso shall be inserted below the existing Regulation 22 (A) of the RVPN ESR, namely:-

"Provided further that the Nigam may specify the posts higher than the entry post of the Nigam Service where direct recruitment is permissible as per the provisions of relevant Service Rules and where besides academic and professional qualifications, specific experience condition is also prescribed, on which the appointment will be made on 'probation' for a period of one year instead of as 'probationer trainee'.

- 2) Following new sub-regulations (iii), (iv) & (v) shall be inserted below the existing Regulation 24 (A) (ii) of the RVPN ESR, namely: -

(iii) On issue of orders of confirmation effective from the completion of the prescribed period of probation, increments as normally due shall be allowed retrospectively.

(iv) On issue of orders of confirmation effective from a date beyond the prescribed period of probation, constituting thereby an extension in the period of probation, increments as normally due shall be allowed retrospectively except that the normal date of drawal of first increment shall be extended by the number of days equal to the period of extension of probation.

(v) Subject to paragraph (iv) above, a person whose initial pay is fixed under Rule 22 of Annexure-A appended with Revised Pay Rules, 2008, of the Nigam, the service rendered on the previous post since the drawal of last increment shall be counted for the purpose of grant of increment in the new post under Rule 14 of Revised Pay Rules, 2008 of the Nigam.
