Any expenditure or taxes incurred or to be incurred by RVPN on account of the execution of work on RVPN's transmission system by the intending agency/consumer shall be borne by intending agency/consumer.

The demand note already issued citing therein GST on transfer of assets may be amended accordingly to avoid any conflicts.

All other procedure, terms and conditions of the original order shall remain unmodified.
