**CIRCULAR**

**Sub:- Recovery of wrongful/excess payments made to Nigam employees/pensioners.**

The Finance Department, GoR vide its circular No. F.9(14)FD/Rules/2005/Pt. dated 09.08.2019 and circular of even nos. dated 20.04.2017 had issued directions as follows: -


- (i) *In all existing cases, fixation of pay of all government servants be thoroughly reviewed and if any error or discrepancy is found it may be rectified immediately. The re-checking of the cases may be initially done by the Head of Office and then it may be got checked from the officer of the Accounts Service and certificate to this effect shall be recorded in the salary bill of August 2017.*
- (ii) *Similarly, increase in pay of Government Servant on any account shall be issued only after pre-check by the member of Accounts service.*
- (iii) *Compliance of the above directions was to be ensured by the Administrative Department/Head of Department from each Head of Office, so that overpayment which is not recoverable as per directions of Hon'ble Supreme Court may not continue for indefinite time/upto retirement of the employees.*
- (i) *It was also directed that non-compliance of above directions will be seriously viewed and for overpayment, if any, noticed after August 2017, responsibility will be fixed against the person responsible for such overpayment and action will be taken under the Rajasthan Civil Services (Classification, Control and Appeal) Rules, 1958.*

In order to control the recoveries and to ensure that overpayment which is not recoverable as per directions of Hon'ble Supreme Court may not continue for indefinite period, it is enjoined upon all salary/pension preparing authority/salary / pension passing authority to review fixation of pay/pension of all Nigam employees/ pensioners thoroughly and if any error or discrepancy is found it may

be rectified by March 2020 and a certificate to this effect be recorded in the salary/pension bill of April 2020 positively.

Non-compliance of above directions will be viewed seriously and action mentioned above be taken against the person responsible for such overpayment.
