
Sub:- Deferment of partial pension of March-20 paid in April 2020-looking to economic slowdown due to COVID-19 LOCKDOWN.



ORDER

**Subject : Deferment of partial salary and pension of March paid April, 2020
- looking at economic slowdown due to COVID-19 LOCKDOWN.**


At present, there is countrywide lockdown due to the threat of COVID-19 pandemic. Owing to negative economic impact caused by lockdown, fall in inflow of revenue and in the view of extra expenditure being incurred to control COVID-19, Government hereby orders for deferment of payment of the salary and pension of March, 2020 paid in April, 2020 including all allowances as per the following :

- (i) There shall be a deferment of 75% (23 days) in the gross salary of March, 2020 in respect of Hon'ble CM, Hon'ble Speaker, Hon'ble Dy.CM, Hon'ble Ministers, Hon'ble Leader of Opposition, Hon'ble Chief Whip/Dy.Chief Whip/MLAs.
- (ii) There shall be a deferment of 60% (19 days) in the gross salary of March, 2020 in respect of all All India Services officers viz. IAS, IPS, IFS.
- (iii) There shall be a deferment of 50% (16 days) in the gross salary of March, 2020 in respect of all State and Subordinate Services Officers.
- (iv) There shall be a deferment of 30% (9 days) in the gross salary of March, 2020 in respect of all other employees except Police Constables, Nursing Staff, Para-Medical Staff, Class-IV employees and all employees drawing salary in L-1 to L-4 of pay matrix.
- (v) In respect of employees/officers of all PSUs/Government Boards/Corporations/Societies/Autonomous Bodies/Local Bodies, their salary shall also be deferred as above.


- (vi) The deductions of G.P.F. and S.I. for the month of March, 2020 shall be deferred.
- (vii) Deductions related to COVID-19 CM Relief Fund will be applicable as prescribed vide Finance (Budget) Department order dated 27.03.2020.
- (viii) There shall be a deferment of 30% (9 days) in the gross pension of March, 2020 in respect of all State Pensioners except Class-IV and L-1 to L-4 of pay matrix equivalent pensioners.

This order is applicable for the salary/pension of the month of March, 2020.
