


These directions will be applicable for all kinds of procurements viz. Goods, Services and Works.

NOTIFICATION**

**G.S.R.254** .-In exercise of the powers conferred by section 55 of the Rajasthan Transparency in Public Procurement Act, 2012 (Act No. 21 of 2012), the State Government hereby makes the following rules further to amend the Rajasthan Transparency in Public Procurement Rules, 2013, namely:-

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Transparency in Public Procurement (Second Amendment) Rules, 2021.  
(2) They shall come into force from the date of their publication in the Official Gazette.

**2. Amendment of rule 75.-** In rule 75 of the Rajasthan Transparency in Public Procurement Rules, 2013, after the existing sub-rule (2) and before the existing sub-rule (3), the following new sub-rule (2A) shall be inserted, namely :-

"(2A) Notwithstanding anything contained in sub-rule (2) above, where the State Government being of the opinion that there exist grave situations such as natural calamity or Pandemic or Epidemic diseases or floods etc. in which the economy is adversely affected, the State Government may, by order, direct the procurement entity to reduce the performance security taken in case of existing contracts of ongoing projects, from such date and on such conditions as may be specified in the order."
