ORDER

The Coordination Committee of Rajasthan State Power Sector Companies, in its 26th meeting held on 30th December, 2020, has recommended as an inter-company coordination issue, to adopt notification No. F. 7(1)DOP/A-II/ 95/Pt.-II dated 18.08.2020 issued by the Department of Personnel, GoR and to make necessary amendments in various Service Regulations and Guidelines for DPC, 2017; namely:-

- (1) The existing proviso appearing in the regulation as mentioned in column no. 3 against each of the Regulations as mentioned in column no. 2 of the following table, shall be substituted by the following:-

"Provided also that any person who performed remarriage which is not against any law and before such remarriage he is not disqualified for promotion under this sub-rule, he shall not be deemed to be disqualified with effect from 01.04.2012, if any child is born out of single delivery from such remarriage."

- (2) In the Guidelines for promotions issued vide circular no. RVPN/ AAO/ F&R/ DPC/ F.80/ D. 136 dated 08.12 2016 (F&R No. 1051), following amendment shall be made; namely:-

- (a) the expression "पांच भर्ती वर्ष" as appearing in clause no 10.5 of Part-I, shall be substituted by "तीन भर्ती वर्ष" ।

(b) the existing clause no. 10.5 (v) of Part-I, shall be substituted by the following:-

"यदि कोई व्यक्ति पुनर्विवाह करता है, जो किसी भी विधि के विरुद्ध नहीं है एवं ऐसे पुनर्विवाह से पूर्व, वह इस उप-विनियम में पदोन्नति के लिए अयोग्य नहीं है, तो वह पदोन्नति के लिए 01.04.2012 से अयोग्य नहीं माना जायेगा यदि इस पुनर्विवाह से एकल प्रसव से कोई संतान उत्पन्न होती है।"
