Recently, SI&PF Department has informed that offline medical reimbursement facility under Medi-claim policy will be stopped for the treatment taken after 31.10.2021. Onwards, for availing cashless medical facility, employees have to register themselves on RGHS portal, as only the cashless medical facility will be provided after 31.10.2021.

To avail facility of E-Card through RGHS Portal following steps are required:


1. Creation of SSOID
2. Creation of Jan-Aadhar Card
3. Registration on RGHS Portal

Therefore, all the beneficiaries of Medi-claim Insurance Policy of RVPN are advised to get enrolled themselves for RGHS E-Card, so that, they can get benefits of Medi-claim Insurance Policy without any hassle.
