ORDER

Sub:- Regarding implementation of RGHS in the RVPN.

The Board of Directors, RVPN, in its 297th meeting held on 11.11.2021 has accorded its approval regarding implementation of RGHS in the RVPN as under:-

1. (a) The RGHS shall be made applicable for the employees appointed on or after 01.01.2004 w.e.f. 01.01.2022. The subscription shall be charged from the employees on the rates at par to the rates decided for the Serving Government employees appointed on or after 01.01.2004 by the State Government from the salary for the month of January, 2022 and onwards, as under:-

Premium @ Rs. 6100/- per employee per annum shall be payable to State Government for RGHS. Therefore, the difference amount i.e.

h

(Total Premium - subscription collected from employees) shall be borne by RVPN.

(b) Presently, the work of Medclaim Policy applicable for the employees appointed on or after 01.01.2004 is managed/ looked after by CPO office. The work of mediclaim policy shall be replaced by the RGHS. Therefore, the CPO shall furnish acceptance letter to SI&PF department in reference to letter No. 150 dated 28.04.2021 and arrange to deposit the premium for RGHS for the period 1st January, 2022 to 31st March, 2022 after adjustment of premium paid for Medclaim policy in such manner that the RGHS may be made effective from 01st January, 2022 for all the employees appointed on or after 01.01.2004.

(c) Provisions regarding registration under RGHS/ RGHS card/claim process/ cashless facilities/ list of approved hospitals and pharma stores will be as per the orders/ circulars issued by the State Government time to time under RGHS.

2. The employees and pensioners/family pensioners appointed prior to 01.01.2004, shall continue in the existing scheme with the following modifications:-

- (a) Approved hospitals/ Public Private Partnership Hospitals/ Referral hospitals for treatment will be at par to the hospitals empanelled under RGHS. Accordingly, after issuance of order, consent shall be taken by the F&R section, RVPN from all hospitals empanelled under RGHS to provide treatment to Nigam's employee and pensioners as per the rates decided under RGHS by the State Government.
- (b) Hospitals, which are in the list of approved hospitals of Nigam but not empanelled under RGHS, shall be continued upto 31st March 2022 for the employees and pensioners who are already taking regular/ follow-up treatment from such hospitals. However, no medical reimbursement facility will be provided for fresh/ new treatment started in such hospitals after the date of issue of the order in this regard.
- (c) Purchase of medicines:-
 - (i) Medicines prescribed by Authorised Medical Attendant shall be purchased only from a shop run by CONFED/ Upbhokta



Sangh or Rajasthan Medicare Relief Society or the Pharma Stores and E-pharma stores approved under RGHS.

- (ii) In case of emergency or non-availability / closing of Co-operative Shop/ empanelled pharma stores under RGHS, medicines upto Rs. 1000/- can be purchased from private shops.
- (iii) In case of indoor treatment, if facility of CONFED/ Upbhokta Sangh or empanelled Pharma Stores under RGHS is not available in the premises of Approved Hospital or the prescribed medicines are not available there, then the medicines can be purchased from private shops without NAC.
- (d) Investigations/ diagnostic tests as advised by the Authorised Medical Attendant can be carried out in laboratories of Government / approved hospitals or the diagnostic laboratories approved under RGHS.
