CPO for Corporate Office being the cadre controlling authority of Class III & IV employees. 4. CEs/ZCEs/Circle SEs in consultation with Zonal DDP/Circle PO for those employees working under their jurisdiction.

Note: Permission for appearing in Competitive Examination (Written Examination/ Interview for joining other services) will not be necessary and an intimation to this effect by the Nigam employee shall be sufficient."
