



**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Medical Attendance) Rules, 2013, namely:-

**1. Short title and commencement.-** (1) These rules may be called Rajasthan Civil Services (Medical Attendance) (Second Amendment) Rules, 2016.

(2) They shall come into force with immediate effect.

**2. Amendment of rule 16.-** In sub-rule (2) of rule 16 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013, for the existing expression "Rs. 500/-", the expression "Rs. 1000/-" shall be substituted.
