CIRCULAR

Display of certificate of registration under Goods and Service Tax (GST)

Goods and Service Tax (GST) is implemented in India w.e.f. 1st July, 2017. Rule 18 of the CGST/SGST Rules deals with "Display of registration certificate and Goods and Services Tax Identification Number on the name board." Which is as below:-

(1) Every registered person shall display his certificate of registration in a prominent location at his principal place of business and at every additional place or places of business.

(2) Every registered person shall display his Goods and Services Tax Identification Number on the name board exhibited at the entry of his principal place of business and at every additional place or places of business.

Please note that in case of breach of Rule 18, a general penalty may be imposed u/s 125 of CGST/SGST act which may extend to twenty-five thousand rupees. Further it is submitted that Rs 25000/- may be levied separately under SGST and CGST Act respectively, i.e. total Rs 50000/-.


