Sub : Display of certificate of registration under Goods and Service Tax (GST)


With Reference to above subject it is intimated that Rule 18 of the CGST/SGST Rules deals with "Display of registration certificate and Goods and Services Tax Identification Number (GSTIN) on the name board". According this rule:-

(1) Every registered person shall display his certificate of registration in a prominent location at his principal place of business and at every additional place or places of business.

(2) Every registered person shall display his Goods and Services Tax Identification Number on the name board exhibited at the entry of his principal place of business and at every additional place or places of business.


In this regard a circular No./RVPN/CAO(P&C-II)/GST/D.1243 Dated 05/10/2017 has been issued by this office for compliance as above but it has been observed some offices have not complied the above. Hence you all are requested to display the GST No. of RVPN and GST Registration Certificate at each place of business of RVPN under your jurisdiction.

In case of breach of Rule 18, a general penalty may be imposed under Section 125 of the CGST/SGST act which may extend to Rs. 25000/- and Rs 25000/- may be levied separately under SGST and CGST Act respectively, total Rs 50000/-.
