

All factories and Establishments including contractors and security agencies where 10 or more employees, employed are coverable under the ESI Scheme. This is a mandatory scheme. Those employees getting salary Rs 15000/- or less are coverable under the ESI scheme.

## EXTENSION OF ESI SCHEME IN ALL PARTS OF 28 DISTRICTS OF RAJASTHAN

1. With effect from 01 August 2016 ESIC Scheme has been extended to all parts of 28 Districts of Rajasthan, except Baran, Churu, Jalore, Karauli & Pratapgarh districts. (Auth: Govt of India Ministry of Labour & Employment Notification No. S-38073/29/2016-SS-I dated 20 July 2016 and ESIC letter dated 11 August 2016, copy attached).
2. ESIC Scheme is mandatory for all employees getting salary of Rs. 15,000/- or less per month.
3. ESI contribution being a statutory requirement is required to be paid both by the employer (@ 4.75%) and the employee (@ 1.75%) in the ESIC notified area.
4. In view of the above you are kindly requested to pass suitable instructions to all concerned under your jurisdiction to commence ESI Contribution of the affected employees wef 01 August 2016 to avoid legal complications and penalties at a later stage.
