It is therefore, enjoined upon all concerned that while applying/getting registration due attention must be taken in this regard.

For example, if SE(T&C- Jaipur Rural), RVPN, Jaipur applies for registration on the online portal of Labour Department or Directorate of Economics & Statistics through SSO ID, the name of Firm/Establishment should be as "SUPERINTENDING ENGINEER (T&C-JAIPUR RURAL) RAJASTHAN RAJYA VIDYUT PRASARAN NIGAM LIMITED, JAIPUR" and while entering the name/address of the office/designation, proper spacing should be taken care between two words. Aadhar Card Number of SE's/concerned officers, authorized as Principal Employer, needs to be used for generating BRN. It is further directed to generate BRN accordingly and intimate to this office by 15.09.2020.
