

**Terms and conditions:-**

1. During the contract period, they shall be entitled to get only fixed consolidated remuneration per month which should not be more than the last pay drawn minus pension, on satisfactory performance to be verified monthly by their controlling officer.
2. They shall be entitled to avail gazetted holidays and paid Causal Leave of 12 days in a year. No other kind of leave shall be admissible to them. For each day's absence without leave, 1/30<sup>th</sup> of monthly fixed consolidated remuneration will be deducted.
3. They shall mark daily attendance through biometric machine/register.
4. They shall be entitled for payment of only fixed consolidated remuneration after completion of the month as payable vide amendment GOR's Circular No.F.17(10)/DOP/A-II/94 dated 26.05.14, as adopted by RVPN vide order No.87 dated 24.09.2014 (copy enclosed)
5. They shall not be entitled to get medical reimbursement as a regular employee.
6. They shall be allowed travelling allowance as per category prescribed in TA Rules, based on his monthly consolidated remuneration
7. The Competent Authority may terminate their services by giving 15 days notice, in case the services are not found satisfactory or on breach of any condition of contract.
8. The above payment shall be charged against the code head 76.193, Ex-employee on contract basis.
9. The re-appointment would be subject to the condition that an agreement is signed between the concerned officer and the retired official on Rs. 10/- Non-Judicial Stamp Paper in prescribed format which is to be notarized.

In case above terms & conditions are acceptable, the above mentioned retired officials shall report to their respective reporting officer for further assignment.
