**ORDER**

A charge Sheet vide memorandum No.06 dated 08.08.2018 was served upon Sh. Mahaveer Singh Rawat S/o Sh. Gulab Singh Rawat, Tech. Helper-III (Seniority No. 440) by the Executive Engineer (220 KV GSS), RVPNL, Ajmer. After finalization of DE, a penalty of stoppage of one AGI with cumulative effect was imposed upon him by the Executive Engineer (220 KV GSS), RVPN, Ajmer vide order No. रा.रा.वि.प्र.नि./अधि.अभि./ (220 के.वी. जी.एस.एस.) /अजमेर/पत्र./जावक. 136 दिनांक 23.07.2019. It is informed by the Zonal Chief Engineer (T&C), RVPN, Ajmer vide letter No. RVPN/Z.C.E.(T&C)/F./Ajmer/D. 1268 dated 12.12.2019 that the Appellate Authority diluted the punishment to recorded warning in view of his apology vide order No. RVPN/ZCE(T&C)/Ajmer/F./D. 819 dated 11.09.2019 and No. RVPN/Z.C.E.(T&C)/F./Ajmer/D.1267 dated 12.12.2019.

As no enquiry is pending and no penalty is imposed upon him, hence, on the recommendation of the Selection Committee and as approved by the Chairman and Managing Director, RVPN, Sh. Mahaveer Singh Rawat, Tech. Helper-III is hereby upgraded to the post of Tech. Helper-II under E&M wing, in terms of criteria as provided in Schedule-II of the TWSR, 1975, inserted vide order No. RVPN/AAO/F&R/F.56(II)/D.162 dated 20.09.2018 (F&R No. 1246) w.e.f. 01.04.2019.

Consequent upon upgradation, he shall be allowed only notional benefit of pay fixation (if admissible) w.e.f. 01.04.2019 and actual benefit shall be allowed to him w.e.f. from the date of joining. He is posted at the same place/office where he is working presently.

This upgradation is subject to submission of affidavit regarding not having more than two children on or after 01.04.2012 and property statement as on 01.01.2019. The concerned controlling officer is hereby directed to ensure the compliance of this condition before taking joining and send the compliance report to the concerned Circle Office.
