
### ORDER

Difficulties are being faced by the field officer as to how the excess run of vehicle hired under rule 32 of RTPP rules 2013, to be approve and which authority of RVPN is competent in terms of item No. 5 of the GoR circular No.F.2(4)FD/SPFC/2017 Jaipur, dated: 19.07.2018 (as amended from time to time).

To overcome the problem of filed officers, the CMD, RVPN in consultation with Director (Finance), RVPN has decided to issue clarifications as follows:-

1. The rates, terms and conditions prescribed vide circular No.F.2(4)FD/SPFC/2017 Jaipur, dated: 19.07.2018 (as amended from time to time) issued as per item No. 42 of S.O. 135 under rule 32 of RTPP rules, 2013 shall not be applicable on the vehicles hired under rule 5 of RTPP rules, 2013 i.e. after adopting "Open Bid" method of procurement.
2. The following officers are hereby authorized to regularize the excess KM run of the vehicles hired under GoR circular No.F.2(4)FD/SPFC/2017 Jaipur, dated: 19.07.2018 (as amended from time to time).
