Sub: - Issue of Tax Invoice, Bill of Supply, Receipt Voucher etc. under GST Law  
Ref:- No./RVPN/CAO(P&C)/AO(P&C-II)/GST/D.747 dated 11/07/2017,  
D.844 & D.845 dated 27/07/2017 and D.952 dated 17/08/2017

Consequent to implementation of GST, each registered dealer is required to issue 'Tax Invoice', 'Bill of Supply' and Receipt Voucher etc. having a Unique Number for each outward supply of Taxable Goods/Services, exempted Goods/Services and Advance Received respectively. Accordingly number Series for issuance of Tax Invoice, Bill of Supply and Receipt Voucher manually was circulated to all offices vide above referred letter.

Now issuance of Tax Invoice /Bill of Supply and Receipt Voucher etc. manually using Invoice series as referred above, is discontinued after 31.03.2018 and w.e.f. 01.04.2018 only SAP generated Tax Invoices/ Bill of Supply/ Receipt Voucher etc. with auto generated unique Invoice Series (ODN) through SAP will be considered valid for issuance to Customers/Vendors for all type of taxable and exempted supply of services and goods and the same will be considered for filing of GST returns and other compliances. Points as per attachment may be taken care before generation of Invoices as above.
