Sub:- Format of Pay-order for payment of GST Tax Liability & filing of GST return from month of Sep 2019.

Ref: Letter No. RVPN/CAO (P&C)/AO(P&C-II)/GST/D.950 dated 16/08/2017 issued by CAO(P&C), RVPN, Jaipur.

Vide above referred letter the format of pay-order for payment of GST was circulated. Considering the discloser requirements of GST Return, 'the format of Monthly GST Pay-Order for the payment of GST Tax Liability and filing of GST Return', is changed. The new formats of GST Pay order along with the supporting annexure was also explained and discussed in the GST workshop held on 23rd Sept. 2019 at JMC building, RVPN and attached herewith for your reference.

All Offices are required to send duly filled and signed monthly Pay Order in the attached new format along with Annexure w.e.f. Pay-Order for the month September 2019. The Sr.AO (EA & Cash) is also required to submit a separate Pay order with annexure as above for Delhi GST Registration No. in addition to Pay-order for Rajasthan GST Registration No..

The pay order in attached format is required to be send to AO(P&C-I) with a copy to AO (P&C-II) latest by 04th day of succeeding month so that the consolidated GST may be deposited in timely manner and interest for delay and penalties may be avoided.

Delay in submission of Pay order and information may cause delay in filing of GST Returns and interest and penalties may be imposed under GST law.


