यह परिपत्र अध्यक्ष, बोर्ड ऑफ ट्रस्टीज, रा.रा.वि.पी.एम.सी.एफ. ट्रस्ट (CMD, RVPN) द्वारा अनुमोदित है और बोर्ड ऑफ ट्रस्टीज, रा.रा.वि.पी.एम.सी.एफ. ट्रस्ट द्वारा आगामी सप्ताह के अनुसमर्थनाधीन है।

आदेश क्रमांक RVPN/AS/GAD/F&R/PMC/F.21/D.987 DT:15.12.2007 के अनुसार यदि किसी धनान्तर न पिछले कुछ वर्षों में वार्षिक नवीनीकरण शुल्क जमा नहीं करवाया है, लेकिन अब वह पी.एम.सी.एफ. सदस्य के रूप में नवीनीकरण शुल्क जमा करके स्कीम में अंशदान जारी रखना चाहता है तो इस दशा में वह वार्षिक नवीनीकरण शुल्क की दृष्टि से जमा करवाकर पुनः सदस्य बन सकता है। हालांकि इस प्रकार के मामलों में बकाया अवधि (Default period) के लिये पुनर्पत्र दावे स्वीकृत नहीं होंगे।

CIRCULAR

The earlier option available for deposition of renewal fee in the respective office where he/she is registered for medical reimbursement facility shall also be available to all the registered members of PMCF.

The pensioner has to email the complete details annexed at Annexure-A and the acknowledgement receipt of payment of PMCF fee to rrvktrust.pmcf@rvpn.co.in with a copy (cc) to the respective office where he/she is registered for medical reimbursement facility. The list of email addresses of all offices is annexed at Annexure-B.

As per order no. RVPN/AS/GAD/F&R/PMCF/F.21/D. 987 Dt. 15.12.2007, "in case where a pensioner has not deposited the annual renewal fee during the past years and now, if he/she wants to contribute as member of the scheme by depositing the renewal fee then he/she can become a member by depositing double annual renewal fee. However, in such cases the reimbursement of medical claims shall not be allowed for the default period".

This bears the approval of Chairman, BoT, RRVPMCF Trust (i.e. CMD, RVPNL) and subject to ratification by BoT in ensuing meeting.
