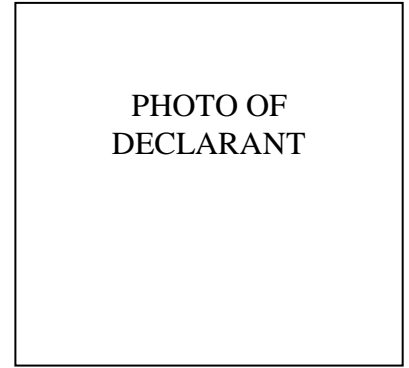

- (1) Temporary contractor's work permit may be issued to electrical contractors of other states (for equivalent class of licence only) to undertake particular work order and for a period as specified in the work order on the payment of fees specified by the State Government. The validity of the permit may be extended on the payment of fees specified by the State Government, if the work order under reference is not amended.
- (2) No licence shall be granted to a person who is under employment of a licenced electrical contractor, unless he/she undertakes to leave the service of his/her employer and to work independently.
- (3) Submit the application form, duly field in, within 60 days from the date of issue of Application from otherwise the Application from shall be treated as cancelled.
- (4) Incomplete application forms shall be rejected or not to be accepted
- (5) Quarterly returns in from 'D' be submitted in the concerning office of the Assistant Electrical Inspector.

## **Documents to be submitted along with application form.**

Application for grant of Licence shall be accompanied with following documents, namely:-

- (a) Specimen signature and three recent passport size coloured photographs (of proprietor or partners or directors of the firm/company) with white background showing the complete face of the applicant(s). The photograph on the application form shall be attested by the Gazetted Officer;
- (b) Demand draft in support of payment of fees for grant of licence;
- (c) Solvency certificate;
- (d) Letters of willingness (in form G-1 & G-2) obtained from Supervisor & Wireman with their full signature, date along with the copy of Permit and Supervisor`s Certificate of Competency (SCC) ;
- (e) The calibration certificate from accredited laboratory by the State Government(s) or Government of India and proof of possession of the tools and equipment mentioned under column 4 of Schedule-I;
- (f) Self-attested copy of,-
  - (i) PAN card(s) & Date of birth certificate (s).
  - (ii) Photo identity proof of the applicant(s) issued by the State or Central Government;
  - (iii) utility bill or bank passbook as a proof of address of business;
  - (iv) Registered partnership deed (for partnership firm) or Memorandum and Articles of Association issued by the Registrar of Companies (for registered firms or company) and authorization letter or power of attorney (in original) issued to the authorized signatory by the partnership firm or company, as the case may be.
