The Labour Department, Government of Rajasthan, vide Notification dated 19.08.2020, has revised the rates of minimum wages, payable under the provisions of Minimum Wages Act, 1948 w.e.f. 01.05.19 for the workers of highly skilled/skilled/semi-skilled/un-skilled categories, as follows: -
